Entering the Facility

You are not permitted to enter YWCA Health + Fitness Centre unless you meet the following conditions, as well each time you tap your membership card at the turnstile for entry, you declare the following:

- 1. You do not have COVID-19 nor are you experiencing symptoms of COVID-19. Take the selfassessment tool
- 2. You have not travelled internationally in the last 14 days, or any area identified as a hotspot by **Public Health Authority**
- 3. You are not in close contact with a person infected with COVID-19

While at the facility

You agree to

- Only visit during your scheduled workout session. Arrive within your scheduled time and promptly leave at the end of your session
- Stay 2 m apart from other members while in the facility
- Follow directional, placement and physical distancing markers in the facility
- Be kind, calm and respectful
- Be aware of and comply with maximum occupancy in each workout area
- Clean all equipment before and after use
- Practice good hygiene •
- Wash hands before and after your workout, after using the toilet
- Sneeze or cough into your elbow •
- Place all tissue, paper towels, towels into the designated bin •

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless YWCA employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
